## 2. Hazards identification

### 2.1 Classification of the substance or mixture

Inorganic glass is not classified as dangerous.

### 2.3 Other hazards

Glass is not dangerous at normal usage.  
Processing of glass, damage or breakage can result in sharp edges. This may cause cuts.

Processing of glass can result in glass dust.  
Acute effects: Respiratory irritation.  
Chronic effects: Possible pneumoconiosis effects.  
Grinding debris and other waste of glass must be disposed consistent with applicable regulations.

#### **3.1 Substances**

As the substance glass is not included in the candidate list of substances of very high concern, currently there are no information duties according to article 33 of REACH. However for the production of glass we may use substances, which are on the candidate list and had been included in Annex XIV of the REACH regulation or could be included in future. These powdery substances are not present as such in the final glass; they are fully integrated into the glass matrix through the melting process. Thus they lose their original characteristics. Glass is an amorphous, inorganic, usually transparent or translucent substance consisting of a mixture of silicates or sometimes borates or phosphates as glass formers. With additions of modifiers a melt is produced at high temperatures, that cools to a solid state without crystallization.
